Bridge Update – Jenny/Bret/Kinsey

Song Sparrow Bridge appears to be complete, but the contractor has one more work session planned. When we get word from the county, our volunteer crews will extend the connector trail, build the elevated approaches, and restore the area around the bridge and creek.

We will be doing a significant amount of rock work at the site, so we want to make sure we have people who have developed skills to build rock walls. We will also have an abundance of restoration work, which will be gratifying for the team.

The plan is to be done with our work at the bridge site by the end of June 2025. The County's ribbon cutting ceremony is planned for Sept 2025.

- Comment from Bret Turner: The last work session was the final on bridge construction. STB may be able to start work in March.
- Comment from Jenny: That's great to hear. However, just a reminder that we won't be starting work until we get official word from the county.

Skagit County Parks and Rec has contracted Art Tuftee (contractor who built the bridge) to build a structure for the Veteran's Trail and one for Hill Creek Trail. Parks Director Brian Adams wants to prioritize the site we identified on Hill Creek Trail to be built first, so it is ready for the bridge ribbon cutting in Sept 2025.

The project is being coordinated by United General District 304 (Beth is planning to join us in March and may have more to share then). Our involvement will be only on Hill Creek Trail, clearing the view to the water and building a short access trail. We'll do this work in alignment with capping that section of Hill Creek Trail. Timing TBD.

- Q from Marcia Fort: Where is the site?
- A: On Hill Creek Trail, a little south of Big Rock. It is a very old living cedar with a hollow at the base. The hollow faces Hansen Creek.
